## AIR-EAGLE® XLT 900 MHz RF Transmitter MODEL 44-1400-1B-DC

### DESCRIPTION

The AIR-EAGLE XLT, MODEL 44-1400-1B-DC is an R.F. transmitter capable of sending a command signal from one pushbutton input and three contact inputs to any Air-Eagle XLT Receiver. The TX and RX combine to create a long range radio frequency system that operates hazardous or hard-to-reach electrical apparatus from safe, convenient locations of up to 2500 feet away (Up to 4 mile range with optional antennas). This unit is user-programmable for up seven network frequencies to allow multiple transmitters and receivers to operate simultaneously in the same area without interference.

### INSTALLATION

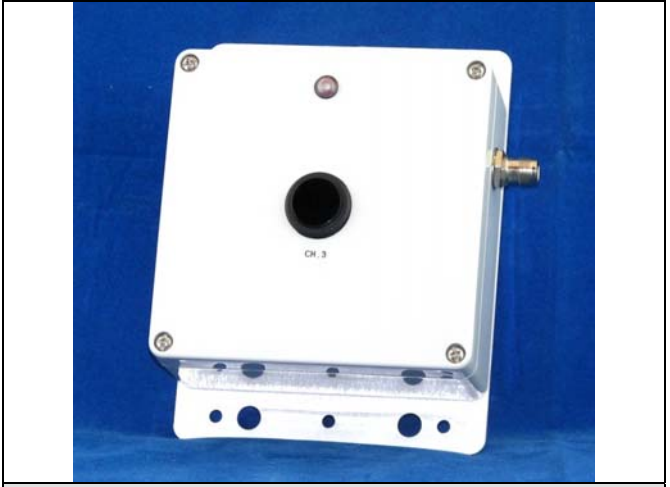
1. Mount the AIR-EAGLE XLT TRANSMITTER in a convenient location.
2. Install wiring to contact input terminal strip.
3. Connect DC power and control to the proper terminals in your control circuit.

### DIGITAL ADDRESS & FREQUENCY SET-UP

This transmitter is factory programmed to Frequency #1 and Digital Address "0". These settings can be changed by the user in any combination **but must match the receiver that is set up to communicate with this transmitter.** **If using this transmitter with a model 44-8000 4-relay receiver, the digital address must be kept at the default of Digital Address "0".**

- 1) Remove power from unit
- 2) Remove top cover.
- 3) Select desired address and/or network frequency using table below.
- 4) Reattach cover and apply power.
- 5) Programming is now complete.

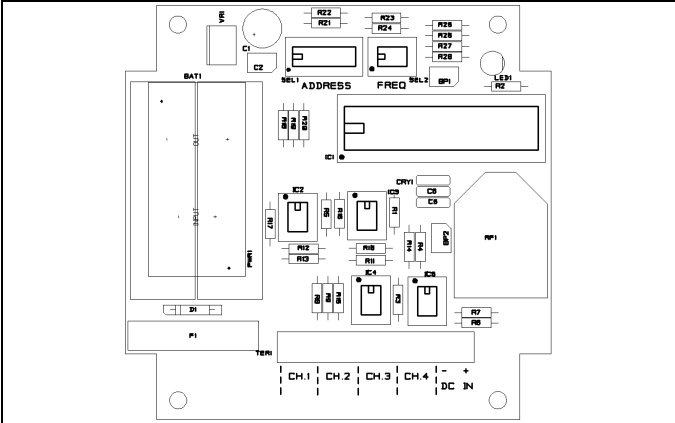
