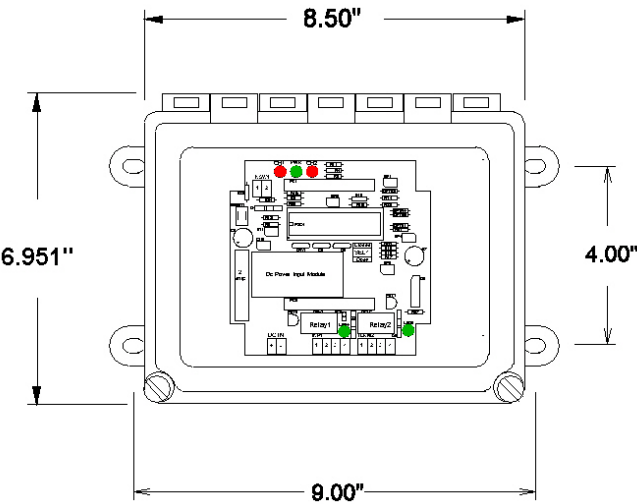

When placed in an area where the signal is weak, this unit will then re-transmit at full strength facilitating greater distances and allowing the RF signal to reach around corners, through tunnels, over hills and through valleys.

DIMENSIONS & INDICATORS



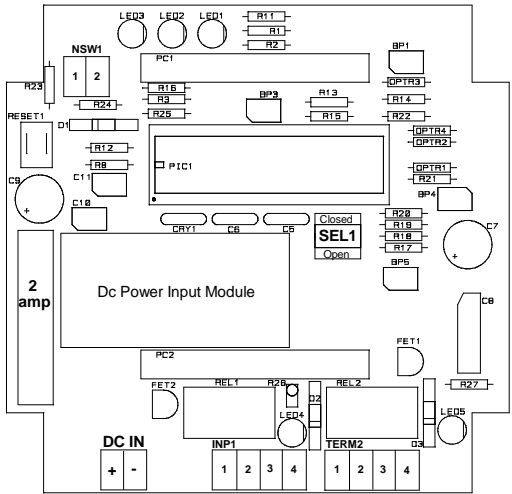
RX LED – Yellow LED illuminates continuously as remote signals are being received by the repeater.

POWER LED – Green LED illuminates continuously while power is applied to the repeater.

TX LED - Red LED illuminates continuously while signals are being re-transmitted from the repeater.
